3. Determine a plan for TrustLands funding for 2022-23, February revisions, vote, Final Report due 3/1/22
  - a. Renea Dietrich proposed we use all of the funds for instructional assistants to fill any gaps created by Covid, and because we have seen the most results from this in the past.
  - b. Rene Cunningham shared that we have utilized the support team of instructional assistants in so many ways as we have navigated through the lack of subs and staff shortages over the past couple of years. We could not have functioned in person without this staff.
  - c. John reported that from the teacher's perspective he sees that students love and trust our instructional assistants and they are very needed to support our students and teachers.
  - d. Kate asked if we are able to spend these funds for an all-day kindergarten teacher.
  - e. Rene Cunningham explained that in the past we have used the funds to pay for a half-day teacher salary. With the efforts and communication of all our enrollment is

growing and since our funding for teachers is based on enrollment, we don't know what the need will be for funding a half-day teacher salary next year. Regardless, we can put funds toward either a half-time teacher or instructional assistants. This has worked well for us over the past three years.
